

COVID-19 SELF DECLARATION AND INDUCTION

If you are coming onto our site, we want you to know that we are acutely aware of the rapidly changing situation regarding COVID-19. We understand that our people, our contractors and the wider public will have concerns about being exposed to the virus.

Before coming on site, we would like to make sure that everyone is aware of vital precautions that are now in place – and which affect your access to our site. In line with the latest government advice, we are strictly reducing contact opportunities, to help stop the spread of COVID-19.

Am not living with someone who has been advised specifically to self-isolate because of close contact with someone who is a probable, suspected or confirmed case of COVID-19

Have not been in close contact with someone who is a suspected or confirmed case of COVID-19.

Will advise the manager/supervisor if any of these conditions change. And provide any contact tracing details of those you may have come into contact while on our site.


